I also fully understand that failure to accept responsibility for inappropriate actions either by myself or my child may result in corrective action or revoking membership. I understand that the Boys & Girls Clubs of Greater Santa Rosa reserves the right to revoke Club membership at any time for any reason.

**Internet Consent:** I give my permission to BGCSR to provide my child internet access from the Clubs' computer learning centers. I understand the purpose of internet access is to enhance education, culture, recreation and competency in an information-driven global society. I understand my child will lose internet privileges if it is deemed necessary by the Clubs' Director. I understand that I can take back my permission at any time, and that my permission automatically stops at the end of the program membership period.

## DISCIPLINE POLICY

In order to ensure the health, safety and welfare of all Club members, staff and volunteers, the Boys & Girls Clubs of Greater Santa Rosa administers the following disciplinary policies and procedures:

**1. The Boys & Girls Clubs of Greater Santa Rosa enforce the following four (4) codes of conduct:**

- a) Respect yourself and other members.
- b) Respect for all staff and volunteers as employees and program leaders.
- c) Respect for Club facilities and equipment.
  - (1) Eating & drinking of snacks & meals are restricted to the cafeteria & picnic tables and benches in the park area only. Gum chewing is not allowed at any time.
  - (2) Proper use of game equipment and touching of machines and other equipment at the request, and under the supervision, of Staff.
  - (3) Not leaving the Club unless signed out by a parent or guardian or by prior written permission by a parent or guardian.

**d) The following are strictly prohibited:**

- (1) Cursing, swearing, racial remarks, or any other form of verbal abuse or inappropriate language.
- (2) Fighting or any other form of physical abuse.
  - (a) Violating the BGCSR "hands off" policy and use of violence of any nature towards any Club member and/or Club staff, including siblings or family members.
  - (b) Bullying or harassment of any Club members and/or Club staff.
- (3) Use, sale, distribution or possession of controlled substances, weapons, and intoxicants. Smoking, chewing or any other use of tobacco products.
- (4) Music containing inappropriate or suggestive language.
- (5) Being defiant or rude to the Club staff or volunteers and/or not following Club rules or directives of the staff

Note: The Boys & Girls Clubs of Greater Santa Rosa reserves the right to revoke Club membership at any time for any reason. If membership is revoked, no dues will be refunded.

**2. Member behavioral infractions related to substance and alcohol use:**

- a) Staff identification of situation or activity:
  - (1) Staff or member may witness or observe activity and share with staff.
  - (2) Staff consultation with involved parties: assess situation, review behavioral contract, expulsion from Club and contacting parent. In accordance to guidelines for discipline; item #3.
  - (3) Parent / Staff meeting: discuss activity, review behavioral contract, referral to counselor.
  - (4) Family / Counselor meeting: staff may be present, review activities and make referral to community agencies and services.
  - (5) Follow-up meeting: staff and family establish behavioral contract and return date of member into the Club.

Note: If the terms of the behavioral agreement are not met by the member and their family, membership rights at the Club may be revoked indefinitely and no dues will be refunded.

**3. Infraction of any of the above, or any other action deemed inappropriate, may result in the following procedures:**

- (1) Discussion: warning and description of the inappropriate action and guidance to avoid reoccurrence.
- (2) Time out: seating for specific period in a specific place.
- (3) Suspension: One (1) to five (5) day suspension from the Clubs and return only after the parent/guardian confers with staff.
- (4) Expulsion: removal from the Club for specific period, indefinitely, or permanently with reinstatement considered following a parent/guardian conference with staff.

**4. Immediate suspension or expulsion may result in any situation where, in the judgment of staff, the safety of any individual is at-risk. Refund of membership fees will not be given.**

**5. Any time a child is removed from the Club, staff will make all efforts to notify a parent/guardian or other responsible family members, or emergency contact.**

**6. Overtime: Any child still at the Club upon or after closing may be dealt with in the following manner:**

- (1) Contact parent/guardian or other responsible family members for pick-up with a fee of \$5 for up to the first five minutes and \$1 per minute thereafter.
- (2) Contact emergency contact for pick-up
- (3) Contact Child Protective Services (CPS) for pick-up
- (4) Contact Santa Rosa Police Department for pick-up

**7. Club staff are not responsible for, and will not, provide transportation to and from the Club or any other destination.**

**8. Club staff may not dispense any medication to a child.**

**9. It is the responsibility of the parent/guardian to assure their child is physically and emotionally capable of properly functioning in the Clubs' interactive atmosphere prior to enrolling in membership and daily visitation.**

**10. The Club is not equipped to effectively deal with profound or consistent disciplinary problems. The Club may act as a referral service to other more appropriate agencies and services.**

**11. Members are free to come and go as they please.** Staff does not grant permission to leave nor do we insist that children stay. Arrival and departure is a matter strictly between parent/guardian and child. The Boys & Girls Clubs of Greater Santa Rosa is not a licensed day care, but a private youth program. The Club and employees will not be held liable should a child leave the premises without permission.

**12. The Clubs enforce the following dress policy:**

- (1) Shirt and shoes must be worn except for appropriate activities in the gym.
- (2) Staff will use their professional judgment and discretion in dealing with other dress issues i.e., hats, bandanas, skirts, pants, shorts, tops, or other identification etc.

**13. Boys & Girls Clubs of Greater Santa Rosa is a private membership organization and Clubs are NOT PUBLIC FACILITIES.** The Club reserves the right to revoke membership or refuse access to any person with or without cause. I also fully understand failure to accept responsibility for inappropriate actions either by myself or my child may result in corrective action or revoking membership.

**14. The undersigned in consideration of participation in this program agrees to indemnify and hold the Boys & Girls Clubs of Greater Santa Rosa harmless and release the Boys & Girls Clubs of Greater Santa Rosa, its board members, employees and agents, from any and all liability for any injury or loss of property arising out of, or in any way connected with participation in this program.**
